- 1- It is notified pursuant to Section 110 of the Securities Act, 2015 that Arif Habib Corporation Limited (AHCL), the holding company of Arif Habib Limited (AHL), have acquired on 2nd May 2018, 1,500,000 voting shares of ORIX Leasing Pakistan Limited (OLPL) at the rate of Rs. 45.02 per share. On account of this acquisition, total shareholding of AHCL in OLPL becomes 7,999,000 voting shares i.e. 5.75% of the total paid-up capital of OLPL. The combined shareholding of AHCL (the holding company), along with the existing shareholding of AHL (deemed to be person acting in concert), becomes 14,427,352 shares which represents 10.36% of the total issued voting shares of the company (OLPL).
