

**PROVISIONAL LISTING OF
ALLIED RENTAL MODARABA****(Managed by: Allied Engineering Management Company (Private) Limited)**

The Karachi Stock Exchange (Guarantee) Limited has approved the provisional listing and quotation of certificates of the Modaraba consequent upon the approval of the Prospectus and completion of relevant requirements under the Listing Regulations of the Exchange. The provisional listing shall take place from the date of publication of Prospectus of the Modaraba in the newspapers i.e. Monday, November 20, 2006 in accordance with "The Regulation for Futures Trading in the Provisionally Listed Companies", (FTPLC), 2002:

1. The trading in the certificates of the Modaraba will commence on this Exchange with effect from **20.11.2006**.
2. In accordance with Clauses 5 and 10 of FTPLC, the following information are provided as per the time schedule submitted by the Modaraba:
 - i) Name of the Modaraba: **Allied Rental Modaraba**
 - ii) Opening date of contract: **20.11.2006**
 - iii) Closing date of contract: **29.12.2006**
 - iv) Settlement Date: **04.01.2007**
 - v) Market lot for trading: **500 Certificates of Rs.10/- each**
 - vi) Maximum number of certificates that of can remain outstanding at the close any business day in any Member's accounts: **1,500,000 Certificates**
 - vii) Date of removal of the Modaraba from the Futures Contract: **01.01.2007**
 - viii) The Modaraba is proposed to be formally listed w.e.f. Monday, January 1, 2007 and accordingly the trading in the certificates of the Modaraba will be shifted to Ready Counter under T+3 Settlement System from the said date. The first settlement date would be January 4, 2007. Notice of formal listing containing the relevant details will be issued separately.
3. All outstanding contracts carried out under these Regulations shall be settled on the settlement date and members shall not be allowed to transfer their positions to the Ready Clearing Board or any other Board.
4. The Exchange may extend the date of settlement if the Modaraba fails to deliver the certificates as per agreed time schedule.
5. A member of the Exchange entering into Futures Trading in the Modaraba shall have to comply with all the provisions contained in FTPLC (as already notified and circulated amongst the members) including those relating to Trading, Deposits & Margins and Clearing & Settlement and the trading in the certificates of the Modaraba will be governed by the said Regulations.
6. The National Clearing Company of Pakistan Limited vide its letter No.NCCP/CF/308/06 dated July 21, 2006 has assigned Modaraba Code/Security Symbol to the Modaraba as "ARM" which may please be noted.
