SUBJECT: MATERIAL INFORMATION – RESUMPTION IN UNINTERRUPTED POWER SUPPLY BY K-ELECTRIC

Dear Sir,

This is with reference to our earlier communication with Pakistan Stock Exchange Limited (“the Exchange”) vide our letter bearing No. ASL/PSX/0085/2018 dated 19 April 2018 whereby we cautioned all stakeholders in the decline in production of rebars by the re-rolling plant of the Company situated at S.I.T.E. Karachi due to load shedding by K-Electric. The utility company was forced to cut power supply in the month of Ramadan to the industry due to the considerable high demand of electric consumption from the residential sector.

K-Electric has now resumed giving us the sanctioned power round the clock, due to which the management of the Company anticipates re-bars production to continue at regular capacity.
