Subject: **NOTICE OF SUSPENSION OF CDS ELIGIBILITY OF FIRST CONSTELLATION MODARABA**

Pursuant to the Order dated February 23, 2012 of the Honorable High Court of Sindh at Karachi in suit no. 01 of 2012 titled First Constellation Modaraba versus Securities and Exchange Commission of Pakistan & Others suspending operation of letter no. SCD/M/HM/FCM/2012-61 dated January 31, 2012 of Joint Registrar (Modarabas), Specialized Companies Division, SECP, also restraining CDC and The Karachi Stock Exchange (Guarantee) Limited ("KSE") for allowing trading (activity) in the certificates of First Constellation Modaraba, and notice no. KSE/N-019 dated February 24, 2012 of KSE suspending trading in the certificates of First Constellation Modaraba ("the Modaraba") with immediate effect, CDC has suspended the CDS Eligibility of certificates of the Modaraba with immediate effect.

The aforesaid suspension shall remain in force till further Order of the Honorable High of Sindh at Karachi.
