CREDIT OF SECOND INTERIM CASH DIVIDEND FOR THE FINANCIAL YEAR ENDING ON SEPTEMBER 30, 2022

We are pleased to inform you that JDW Sugar Mills Limited (the “**Company**”) has credited **Second Interim Cash Dividend** (Net of taxes) into the designated bank account of shareholders on **August 16, 2022**. Breakup of said cash dividend is clarified herein below:

The board of directors had announced above interim Cash dividend on July 25, 2022 @ **Rs. 7.50/- (75%)** per share for the financial year ending on September 30, 2022 in the following manner:

- a) **Rs. 5.00 (50%)** per share from **Sugar Division** profits of the Company for the financial year ending on September 30, 2022 and is subject to deduction of income tax under normal regime i.e. @ 15% for **Filer** and 30% for **Non-Filer** as prescribed in the Income Tax Ordinance, 2001; and
- b) **Rs. 2.50 (25%)** per share from **Power Division** profits of the Company for the financial year ending on September 30, 2022 and is subject to income tax under special regime i.e. @ 7.5% for **Filer** and 15% for **Non-Filer** as prescribed in Clause 18-C of Part-II of Second Schedule of the Income Tax Ordinance, 2001.
