Notes:

1. The Share Transfer Books of the Company will remain closed from March 21, 2016 to March 28, 2016 (both days inclusive).
 2. Any person who seeks to contest the election to the office of director shall, whether he/she is retiring director or otherwise, file the following with the Company Secretary at the Registered Office of the Company not later than 14 days before the day of the above said meeting:-
 - (i) His/Her intention to offer himself/herself for election of directors in terms of section 178(3) of the Companies Ordinance, 1984, together with the consent in Form 28.
 - (ii) A declaration that he/she is aware of duties and powers under the relevant laws, Memorandum & Articles of Association of the Company and Listing Regulations of Stock Exchanges. The person shall also confirm that he/she and his/her spouse does not engage in business of stock brokerage, he/she is not a director in more than 7 listed companies including this company and his/her name is on the register of National Tax Payers.
 3. A member entitled to attend and vote at the Extraordinary General Meeting is entitled to appoint another member as a proxy to attend and vote instead of him/her.
 4. The instrument appointing a proxy must be received at the Registered Office of the Company not later than 48 hours before the time fixed for the meeting. A member shall not be entitled to appoint more than one proxy. If a member appoints more than one proxy and more than one instrument of proxy is deposited by a member with the Company, all such instruments of proxy shall rendered invalid.
 5. An individual beneficial owner of CDC entitled to attend and vote at this meeting, must bring his/her CNIC or Passport in original to prove his/her identity and in case of a proxy, must enclose an attested copy of his/her CNIC or Passport along with CDC A/C No. Representatives of corporate members should bring the usual documents required for such purpose.
