
## **Subject: Material Information**

Pursuant to requirement of Section 15D of the Securities & Exchange Ordinance, 1969 and clause (xx) of the Code of Corporate Governance under the Listing Regulation No.35, it is hereby notified that keeping in view the expected rise in the domestic and international demand of grey fabric and in order to achieve better overhead absorption, the Company has increased its production capacity by installing additional 48 High Speed Air Jet looms (imported from PICANOL) along with ancillary equipment. The cost of this new weaving shed is around Rs.550 Million which has been partially financed from bank borrowings of Rs.317 Million under Long Term Financing Facility arrangement. The plant commenced its operations effective from January 07, 2015.
