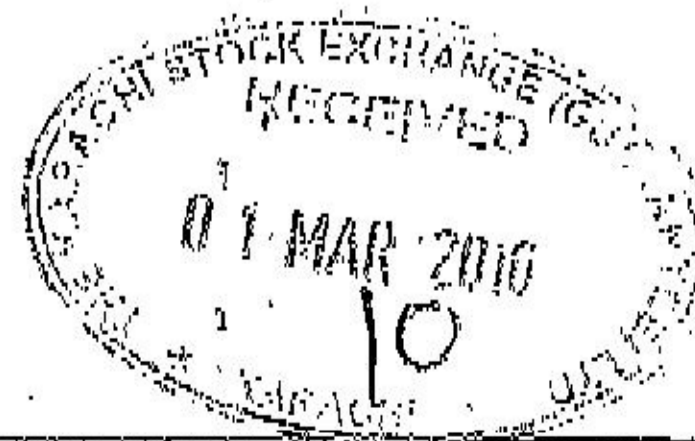
Dear Sir,

With reference to the subject, we would lay down following few line for your information and record.

The company was declared sick unit under section 282-N of Companies Ordinance 1984 by SECP and under section 282-E & F, CEO & Board of Directors were suspended and Administrator was appointed to manage the affairs of the company vide SECP's order No.SC/NBFC-1/IHM/NLCL/2008/72 dated February 15, 2008.

Mr. Nasier A. Sheikh, being Administrator (appointed by SECP as referred in aforementioned para) discharged his duties up to January 31, 2010.

Now, Honorable Sind High Court vide its orders dated February 1<sup>st</sup>, 2010 under the seal and signature of its Judge has replaced the Administrator with Official Assignee. Mr. Kadir Bakhsh Umraani, (Official Assignee - appointed by Honorable Sind High Court - Karachi) so far only asked for statement of affairs & relevant documents of the Company, which were accordingly submitted to him. However, Mr. Kadir Bakhsh Umraani has not yet taken over the charge of office of the CEO of the Company. (Copy of orders of Sind High Court is attached for reference).
