This is to notify that consequent to:

- appointment of Official Liquidator of Natover Lease & Refinance Limited (hereinafter referred to as "Issuer") pursuant to the order of Honorable High Court of Sindh vide order dated March 21, 2013 as informed by the Official Assignee vide their letter no. OA/866/2013 dated March 30, 2013 addressed to KSE;
- resultant delisting of Ordinary Shares (Security Symbol: NLRL) and Preference Shares (Security Symbol: NLRLXI) of the Issuer (hereinafter referred as "said Securities") by the Karachi Stock Exchange Limited with effect from Monday, May 06, 2013; and
- withdrawal of Rule 7 Directive by SECP vide letter reference no.8(4) SMD/SE/2008 dated June 27, 2013 in respect of NLRL & NLRLXI,

CDC has decided to revoke the CDS Eligibility of said Securities under Regulations 5.5A.1 with effect from Wednesday, July 03, 2013.
