This is further to our notice no. CDC/LCR/218/2016 dated September 09, 2016 notifying further extension of suspension of CDS Eligibility of Term Finance Certificates (15-02-08) (Security Symbol: PACETFC) of Pace (Pakistan) Limited (hereinafter referred to as the "Issuer") for 60 Business Days commencing from September 15, 2016 on account of its failure to settle the CDC invoices in accordance with the Fees & Deposits Schedule in discharge of its obligation under the CDC Regulations.

Considering that the Issuer is continuously in default to settle the outstanding dues, Central Depository Company of Pakistan Limited has decided that the CDS Eligibility of Term Finance Certificates (15-02-08) of the Issuer shall remain suspended for a further period of another 60 Business Days commencing from December 13, 2016.
