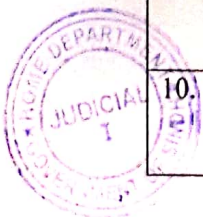

In pursuance of Government of Sindh Notification No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 constituting a Committee (consisting of Additional Chief Secretary (Home) as Chairman, Secretary (General Administration) as Member and Secretary Labour as Member/Secretary and re-constituted again dated 08.04.2020 with addition of Secretary Industries and Commissioner Karachi Division as members to redress and resolve any issues of importers and exporters that may crop up during the lockdown in Sindh. The committee examined the requests/applications received from the export-oriented industries in the light of order No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14 April 2020 wherein such industries were allowed to operate subject to the condition of ensuring SOPs issued vide order No. SO(Jud-I)HD/8-1(04)/2020-Corona-SOPs dated 14 April 2020 in view of COVID-19.

The record received from Labour and Human Resource Department was examined and the following export-oriented factories/manufacturing units were found to fulfill the criteria as per the above order and SOPs {i.e. (i) Verification of export order by TDAP, (ii) Undertaking by CEO/owner on ensuring arrangements within their premises as per SOPs referred above for COVID – 19 prevention, and (iii) List of workers/staff/management who will be present/working in the premises of factory/manufacturing unit during its operation}.


