Start-up and Commissioning of Adhi NGL & LPG Plant-III

Start-up and Commissioning of Adhi NGL & LPG Plant-III of Pakistan Petroleum Limited has been commenced at Adhi Field followed by initial sale of gas of 4 MMscfd which will be gradually increased during Plant's Performance Testing. Plant III is expected to provide ~10-15 MMscfd of additional sales initially which will increase to 15-24 MMscfd after the completion of drilling of the development wells Adhi-25, Adhi-26 and Adhi-27. The additional volume of oil and LPG are expected to be 1500-2500 BBls. and 50-80 M.Ton.
