This is to inform that PPL, Operator of Gambat South Exploration License (having a 65% working interest) has discovered hydrocarbon from its exploratory well Hatim X-1, located in district Matiari, Sindh. Hatim X-1 well was drilled to test the hydrocarbon potential of sands of Lower Goru Formation.

During testing, the well flowed 56.15 MMscfd of gas at 48/64" choke.
