### Disclosure of inside information by listed company

MOL Pakistan Oil and Gas Company B.V (MOL) as the Operator of the Tal Block has tested hydrocarbon at exploratory well Tolanj West-1 in the TAL Block, Pakistan.

The well was drilled to the depth of 4941m MD, targeting to test the hydrocarbon potential of Shinawari, Samana Suk, Lumshiwal, and Lokhart formations. During testing, the well flowed gas in Lumshiwal formation at a rate of 7.48 mmscf/d. The well is under clean-up period.

TAL Block is operated by MOL whereas PPL, OGDCL, POL and GHPL are the joint venture partners.
