This is to notify that consequent to the suspension of trading in the **Ordinary Shares ("Said Securities")** (Security Symbol: NIB) of NIB Bank Limited ("the Issuer") by the Pakistan Stock Exchange Limited ("PSX") with effect from July 05, 2017, as notified by PSX vide notice no. PSX/N-3981 dated June 22, 2017, the Central Depository Company of Pakistan Limited has decided under Regulation 5.3.1 of the CDC Regulations to suspend the CDS Eligibility of said securities of the Issuer with effect from Start of Day on **Wednesday, July 05, 2017**.
