Re: Resuming CDC Eligibility of Security of our Company


Dear Madam,

This is with reference to your letter no. HCL-C-0152018 dated April 14, 2018 and our subsequent telephonic discussion with your representative on the captioned matter subject where we were apprised that the Securities and Exchange Commission of Pakistan has withdrawn the proceedings initiated against Hallmark Company Limited ("**HCL**") vide Order dated April 04, 2018. You also requested us to resume the CDS Eligibility of Ordinary Shares of HCL.

As apprised you earlier that **the CDS Eligibility of Ordinary Shares of HCL was revoked by CDC under the CDC Regulations vide notice dated June 17, 2013** (copy enclosed) on the directive of SECP. Since SECP has withdrawn its proceedings against HCL which has also resulted in removal of cause of suspension of trading in the shares of HCL as notified by Pakistan Stock Exchange Limited vide notice no. PSX/N-2395 dated April 16, 2018, CDC may consider request of HCL for joining the CDS.

Please note that for induction of Ordinary Shares of HCL in the CDS, same will have to be declared once again as CDS Eligible Securities subject to fulfillment of regulatory requirements. Our Operations Department will assist you in completion of necessary formalities in this regard.
