Jibran detained for 'violating judge's protocol'

Social activist and advocate Jibran Naair was released after a brief detention at the Feroze police station after he allegedly attempted to block the vehicle of a senior member of the judiciary here on Monday. Feroze

Police took Jibran into custody near Karachi Club and kept him detained for about one hour at the station. Jibran is contesting the upcoming general election from National Assembly Constituency NA-247 and Provincial Assembly PS-111 as an independent candidate.

"I was forcibly taken into custody by the police personnel who were protocol officer of a judge," alleged Naair in a video message on social media. He claimed that protocol vehicle of pushed his vehicle and in result it collided with the footpath.

"Responding to act I tried to stop the police personnel but in return I received blow with gun chamber from the protocol official," he added.

Naair further informed that he submitted an application seeking inquiry of the incident at the Feroze Police Station. "I want to know under what authority judge ordered to practice such act," said annoyed Naair in the message. He also confirmed that after detention of an hour he was released. On the other hand, police said that Jibran Naair was brought station but after verification he was allowed to leave. Police further said that investigation is being carried out to find the real facts of the incident.

Authorities all set for rain emergency

The municipal authorities made tall claims that rain emergency has been imposed in the city after prediction of heavy rains in the megacity.

According to details, the Sindh Solid Waste Management Board (SSWMB) on Monday in a statement stated that rain emergency will continue till the next orders. The Managing Director of SSWMB Saad Ahmed Mangochi in his statement stated that a plan has been shaped to provide relief to the residents of District East, District South and District Malir.

He further said that a team of the SSWMB has initiated work to lift garbage from jurisdiction of fisheries, Karachi Fish Harbour Authority and Karachi Port Trust while garbage lifting work also continue from surrounding areas of these authorities.

The director also visited at various locations within the jurisdiction of above said that the authorities and directed the concern officials and Chinese company to ensure swift operation of lifting work in the jurisdiction of Karachi Port Trust, Karachi Fish Harbour Authority and Fisheries. On the occasion, he further directed the concern officials to take measures to provide relief to the citizens during rains and also make sure the lifting of garbage from dumping sites on time from across the city.

The director informed that special teams also been formed at district level to address the complaints of citizens during rain while arrangements of municipality and other organizations also been finalized to sweep the rain water.

Despite the claims made by the managing director heaps of garbage witnessed at the corners of the city while people of the district central, district west, district east and other districts complaining that the garbage lifting work had witnessed couple of months ago, made by the authority but recently heaps of garbage exposed the claims of the authority.

Traditional political environment yet to be seen in Karachi

Political parties failed to create the traditional enthusiasm witnessed in urban Sindh politics ahead of the general elections scheduled to be held on July 25. According to the details, urban politics of the province witnessed strong party structure with ideologically strong party candidates particularly during election campaigns in last many decades. For the first time in last couple of decades parties showing such an interest in urban Sindh politics and fielded their candidates with an objective to achieve maximum in the upcoming general elections.

Currently, political parties awarding tickets to the candidates having sound financial resources, instead of ideologically strong candidates. The candidates of different political parties believed in the investment of rupees two million for the constituency of provincial assembly while some five million for the national assembly contest.

Talking to The Nation, Hamid Khan Sherwani, an angry local leader of PPP

contesting from PS-99 as an independent candidate, revealed that PPP awarding tickets to the candidates having strong financial background. He cited that the PPP awarded ticket to Lala Rohan because of the strong financial background but the same ticket has been given to another more wealthy man Shahab Akbar. He alleged that the tickets had been distributed among the candidates on favoritism therefore he decided to contest as an independent because he used to work for the people of the said constituency since last many years in terms of leasing of their Ghats, providing electricity and water. He said that PTI candidate Malwan Adil Shaikh running a rich campaign, spent number of PTI office, using dozens of vehicles including intercity buses and expensive jeeps, cars roaming in the constituency.

Following the code of conduct given by the election commission ahead of the expenditures of campaign also cause to dull the cultures of elections as candidates having limited resources unable to hire office, buses and vehicles to run the campaign.

Traditional politically dominated areas of different political parties are trying to do the creative election environment in their dominated areas like Mirpur, Malir, Lamha, Korangi and other outskirts of the city where PPP and Muhajir Qaumi Movement (MQM) trying gear up for the election campaign. Professor Dr. Taseed Ahmed while talking to The Nation said candidates of different parties lack of public response and an extreme criticism during the campaign but it's a good sign to mobilize the voters. He said that scenario in Karachi's election campaign has totally changed as Pakistan People's Party Chairman Bilawal Bhattar Zardari, Muttahida Qaumi Movement Pakistan leader Dr. Farooq Sattar, Pak Sarvaan Party leader Chairman Mustafa Kamal, PTI leader Dr. Amir Liaquat and various other party leaders and candidates facing public anger during running campaign. Dr. Taseed Ahmed added that public criticism with the leaders a good sign as leader should be accountable before the voters. He said that it's essential for the political leaders

to face public anger to mobilize the voters. He pointed out that if political parties fail to create election environment till the next week affecting the voters behavior and also strengthen the position of MQM founder Altaf Hussain.

An interesting skirmish within the political parties also witnessed here in the metropolis for party tickets even in MQM party workers showing their reservations over the distributions of the party tickets. There are number of political party supposed to replace the MQM in upcoming general elections of 2018.

It's widely believed that in current political situation, MQM all factions would boycott the elections as London chapter of the MQM has already distanced itself from the election process. Previous elections witnessed that the Urdu speaking voters used to cast their votes to MQM founder Altaf Hussain and candidates not even bear the expense of a single corner meeting as party unit and sectors of their areas used to arrange everything for the candidates.

DHA assures commission of not discharging untreated water in sea

The Supreme Court-mandated water commission Monday sought comments from the federal secretary power & energy regarding supply of water and treatment plants. The commission has also directed cantonment board of Clifton to clear the Water Board's arrears within one month.

One-man judicial commission headed by Justice (r) Amir Hani Muslim conducted hearing pertaining supply of water and sanitation issues in the city.

Defence Housing Authority (DHA) assured the Sindh Water Commission (SWC) that no untreated water from phases V, V-Ext, VI & VIII will be discharged in the Arabian Sea, after April 2019. Also, waste water from remaining phases would be treated through integration with TP-

IV at the cost of DHA by 2020, a report submitted by DHA in the commission. The commission deliberated upon host of issues and issued directives while disposing of the different issues.

Commission directed some modification in the report of DHA by stating that the capacity of STP at Qabul Khan (Sea View) should be raised to 2 MOD in instead of 1.5 MOD. The completion date shall remain the same which is April, 30, 2019.

The DHA shall take up the issue of getting the treated water back separately at subsequent stage after meeting the requirements set by the Water Board. Commission directed that the arrangement proposed by the DHA shall be subjected to payment of dues to KIV&SB for the facility provided by them through main trunk of TP-IV.

Commission observed that an integration of DHA sewerage will be

allowed into any other system either from TP-V or otherwise. DHA shall ensure that no untreated waste is discharged into the sea or in any other system after the deadline given in the report.

It was directed that the increase in supply of drinking water shall depend on overall availability of water in the KW&SB system. The Water Board and directed to issue notices to the Cantonment Boards where flow meters have not been installed inclusive of MES formation.

These flow meters shall be installed by the relevant Cantonments/MES formations within the period spelt out in the proposed notices at their costs.

The MD Water Board told the commission that there are areas which are pending against the monthly billings. Commission directed that Cantonment board shall clear the arrears within one month.

Minister refutes PPP's allegations

Caretaker Information Minister Jameel Yusuf has refuted the allegations and apprehensions leveled by the Pakistan People's Party (PPP) leadership over his comments on the violent protest in a small area of Lyari during the election campaign of Bilawal Zardari.

While strongly condemning the violence and use of stones or sticks as it clearly comes under the purview of acts of terrorism, there is no question condoning any such incidents.

He further clarified that no specific statement against the PPP or any other party of such was made by him. The statement under concern was a generalized reply to a question by the electronic media on the failure of upholding a free and fair election campaign due to this unfortunate incident.

In his statement, he showed apprehension against the several election situations to be of a very sensitive nature and made it clear that we are bound to uphold and ensure the Code of Ethics, as identified by the Election Commission of Pakistan (ECP), with the sup-

port of all parties. The all political parties and independent candidates will get equal security and media coverage, as it is their right. He stated the only concern that needed to be emphasized was that there are terror alert warnings issued by all agencies and also by the ECP.

The representatives of political parties must coordinate with the district administration to plan and ensure the safety and security of their campaigns for which the entire caretaker setup is there to assist in extending the same, as repeatedly assured by Sindh CM Fazal-ur-Rehman.

BLA member arrested

Police Monday claimed to have apprehended a key member of the separatist party of the Balochistan ally (BLA) involved in assassination of a top police officer of Sibi, Balochistan.

The accused was arrested during a routine patrol by District Korangi police. His arrest was made during a press conference held by District Korangi SSP Sajid Siddiqui. The accused arrested was identified as Muhammad Salah alias Hajj son of Jamna Khan.

The police also claimed to have recovered arms and ammunition from his possession. Police officials said that the accused arrested was associated with Holic Liberation Army. According to SSP Siddiqui, the accused was arrested during a police patrol in Landhi locality when the Landhi SHO Sarwar Gomanish was busy in routine patrol in the area, adding that the police interrogated and arrested the accused and shifted him to the police station where the police interrogated him.

Police officials while quoting the initial interrogations said that the accused has confessed that he along with his at least seven companions to whom at least four have already been killed a and to kill SHOs in the border area of Sibi and Balochistan on gunpoint in 2003 and used to sell them to the Mazri tribe people through a gang leader Zafar Haywan.

The accused further confessed that in June 2003, they were busy in routine snatching of vehicles when they attempted to intercept a vehicle bearing government number registration plate, however, the driver sped up the vehicle instead of stopping and the police guards opened indiscriminate fire at them, however, he and his companions also retaliated. During an exchange of fire, one of his companions, namely Sabir Iqbal was killed. "We didn't have any idea about the people travelling on a SUV at the time of incident," the accused claimed. "But later we found that it was the deputy inspector general of Police DGP Sibi, Balochistan Abdul Aziz Bilal."

During the exchange of fire, DGP accompanied by a driver and gunman was killed while another gunman was wounded. One of his companions, namely Yahu had a rocket launcher while the other militants had Kalashnikovs with them during the exchange of fire, the suspect confessed, adding that he and his companions later managed to escape and bring in hiding. Police officials said that the case has been registered while further investigation was underway.

Meanwhile, police claimed to have arrested at least 13 accused persons in areas raid conducted in different parts of the city. The accused persons arrested were wanted to the police in different sort of criminal activities while police recovered weapons from their possession.

Anti-graft body lead removed

ACE DG blamed for creating hurdles in Saaf Pani scam probe | Call-up notices displayed outside Shehbaz's residence for July 5 | Fawad may appear today

The head of the Punjab anti-corruption body was removed allegedly for creating hurdles in the investigation of Saaf Pani Company case, official sources said on Monday.

Director General of the country's anti-corruption establishment Brig (R) Muzaffar Ali Ranjha was relieved of his duties, an official said. However, Punjab's Additional Chief Secretary Tariq Naeem Najmi was given the additional charge for the post of DG, AC.

According to sources, Ranjha had tried to block the provision of Saaf Pani Company's record in the national accountability bureau. But following the intervention of the country's top court the initial record was provided to authority.

Currently, NAB officials are examining the whole record as part of investigation involving public sector companies, PML-N President

and former chief minister Shehbaz Sharif is bound to appear before a combined investigation team of the NAB on July 5. The call-up notices have already been displayed outside both the residences of the politicians in Lahore's Model Town.

In March, the anti-graft watchdog initiated an inquiry against the director general and regional directors of the Anti-Corruption Establishment in Punjab. A high-level combined investigation team was also for the inquiry issued on the orders Chairman NAB Justice (C) Javed Iqbal.

Last week, the NAB's Bureau in Lahore summoned former CM Shehbaz Sharif to appear before the combined investigation team on July 5 in connection with the Punjab Power Development Company case.

The call up notices were issued one day after Javed Iqbal suggested the politicians to continue their election campaigns but also appear before the authority when they are summoned.

Shehbaz Sharif, early last week, skipped NAB proceedings in connection with Saaf Pani Company case and rushed to Karachi to launch the election campaign. The NAB's Lahore Bureau had asked the former Chief Minister to appear before the authority but he ignored summons and left for the port city to kick start the campaign.

The Saaf Pani Company and the Punjab Power Development Company Limited are among the 56 public sector companies established by PML-N government in Punjab since 2008. NAB had issued legal last year had ordered a probe into the 56 companies over allegations of embezzlement, corruption and irregularities.

In April, Shehbaz Sharif's son-in-law Imran Ali Wazir had also skipped appearance in the NAB in a corruption case related to the same Punjab Power Development Company.

PTI leader Azeem Khan and PML-Q leader Moinuddin Khan are also summoned by the anti-

graft body on July 10 and July 13 respectively in connection with different corruption cases, in addition to PML-N President Shehbaz Sharif.

Former MNA Mudasar Qayyum Nara and PML-N's candidate for National Assembly Saif-ur-Matloob Khokhar appeared before the combined investigation team of the NAB last week. Both the influential politicians were called for having assets beyond means.

Meanwhile, Fawad Hassan Fawad, former Principal Secretary to ousted Prime Minister Nawaz Sharif has also been summoned by the authority at the NAB Bureau in Lahore on Tuesday (today).

Earlier, Fawad was summoned in connection with Ashiyana-a high-end housing project but he had failed to answer the questions raised by the combined investigation team. Reportedly, NAB has obtained complete detail of the assets owned by Fawad from the Federal Board of Revenue.

ASHIYANA HOUSING SCAM LHC turns down bail pleas of six accused

The Lahore High Court on Monday dismissed bail petitions of six accused, including close relatives of former LDA DG Ahmad Khan Cheema, in the Ashiyana Housing scheme scam.

The six accused are Ahmad Cheema's brother-in-law Mansoor Ahmad and cousin Ahmad Hassan, Paragon City Director Munir Zia, LDA officer Sajid Bhutta, Punjab Land Development Company (PLDC) CEO Imtiaz Haider and its consultant Bilal Qidwai.

Mansoor Ahmad, the brother-in-law of Ahmad Khan Cheema, and Ahmad Hassan, his cousin, had been on the interim bail, while Bilal Qidwai Engineering Director Munir Zia and LDA officer Sajid Bhutta approached the high court for the first time to secure pre-arrest bail. PLDC CEO Imtiaz Haider and its consultant Bilal Qidwai had moved the court for after-arrest bail.

NAB authorities had filed reference against former LDA DG Ahmad Khan Cheema and others in the case according to which Cheema caused Rs660 million loss to the national exchequer in Ashiyana Housing scheme while cost of the project increased to Rs3,399 billion. At least 6,000 people who had applied for houses in the project suffered, it said.

The court for the accused told the court that the NAB made fake cases against his clients as they had nothing to do with the scam. He asked the court to accept the bail and order their release. The NAB counsel however opposed their bail petitions arguing that Ahmad Khan Cheema misused his authority as LDA DG and got huge land in gratification.

Askari reiterates commitment to free, fair elections

Punjab Caretaker Chief Minister Dr Hasan Askari held a detailed meeting with Caretaker Minister for Local Government, Energy and Provincial Disaster Management Zafar Mehmood.

During the meeting, different matters including arrangements for upcoming general elections, implementation of electoral code of conduct and steps for dealing with monsoon and possible threat of flood came under discussion.

Talking on the occasion, Dr Askari said the caretaker government was ensuring implementation of electoral code of conduct issued by the Election Commission. He said that legal action will be initiated on any violation of the code of conduct and every possible step will be initiated for provision of facilities at polling stations. He said that holding of free and fair elections is the first priority of the government. "We are committed to holding of general elections in an impartial and transparent manner and foolproof arrangements are being made for achieving of this important objective at every level. Provision of peaceful atmosphere for polling will be ensured on July 25 so that voters could use their right of franchise without any fear and danger," he said.

He said that all possible steps will be taken so that voters could use their right of franchise independently and voters

commissary will be used for monitoring the sensitive polling stations. The utilization of information technology will also be made for peaceful and transparent holding of general elections and implementation of electoral code of conduct of the Election Commission will be ensured at every cost. He said that water situation in the rivers should be monitored round the clock and all arrangements should be completed so as to deal with any untoward situation, concluded the chief minister.

Also, Punjab Caretaker Chief Minister Dr Hasan Askari held separate meetings with Vice Chancellor of Punjab University Prof Dr Niaz Ahmad Akhtar and Vice Chancellor of Government College University Lahore Prof Dr Hassan Amir Shah at Chief Minister's Office here yesterday.

On the occasion, the VCs briefed the chief minister about the performance of their institutions and the development made in the field of education. Talking on the occasion, Dr Askari said that giving modern education to students was the need of the hour as promotion of modern education and skills development are the basis of development. The nation has given due attention to skills development and latest trends in education existed in the development process. He said that it is the prime responsibility of the government to provide best opportunities of higher education to the youth and added that every possible effort will be

made for the betterment of education sector.

Separately, Askari said that provision of quality healthcare facilities was the basic responsibility of the government. Funds will be provided for ongoing healthcare schemes and other public welfare projects. "The caretaker government cannot initiate long-term schemes, however, it is our effort that steps should be taken on a priority basis for healthcare schemes that can be completed in a short span of time," he said. He said that every possible effort will be made for welfare of public within the constitutional limits. He said that he will personally monitor the situation by visiting different hospitals.

He said that healthcare system is of utmost importance for public welfare and every possible effort will be made to improve the health services within the mandate. Dr Askari said that effective monitoring of healthcare programmes is very essential as steps taken for the service of ailing humanity should be implemented in letter and spirit and patients should be provided quality healthcare facilities at the hospitals.

He expressed these views while talking to caretaker health minister Dr Jawad Sajid Khan who called on him at Chief Minister's Office here yesterday. During the meeting, steps were discussed to further improve healthcare facilities as well as the ongoing health sector schemes.

OPD opens at Jinnah

Minister for Specialized Healthcare and Medical Education Dr Jawad Sajid Khan inaugurated upgraded orthopaedic outpatient department at Jinnah Hospital on Monday.

The department has been renovated in three months at a cost of Rs3.5 million provided by the philanthropists. Faculty of Allama Iqbal Medical College, Head of Orthopaedic Department Prof Tahseen Bhatti, philanthropists, administrative doctors and paramedics were also present. The minister observed process of issuance of tokens, sitting arrangements for patients and attendants, handling of patients at four terminals each comprising one consultant and two junior doctors. He also witnessed ongoing rehabilitation work at orthopaedic ward and upgradation of operation theatre. Bed capacity of ward will be increased from existing 30 to 60 after upgradation to be completed within a fortnight. Philanthropists have given Rs10 million for renovation of orthopaedic ward. Ongoing renovating and upgradation of operation theatre will be completed within a month. MCI employees protest against privatisation of sanitation directorate

 Dozens of Metropolitan Corporation Islamabad employees on Monday staged a protest demonstration against the decision of privatising the sanitation directorate of the Corporation, in front of the Mayor's office here.

Labour Union to help them stop privatisation of the sanitation directorate. The CDA had assured the labour union to take up the issue with the MCI. The union representatives had last month held a meeting with the CDA high-ups to discuss privatisation of the directorate and other issues pertaining to CDA employees. On request of the Labour Union representatives, DG Civic Management assured to take up the issue with MCI high ups.

But the directorate of sanitation, MCI continued with the plan and invited bids for privatisation of cleaning services including cleaning, sweeping, collection and transportation of solid waste from sector G-6, G-7, G-8, G-9, G-10, G-11, 14, Blue Area, Kashmir Highway, Expressway, Lohra Road, Farah Town, Hakim etc. Islamabad under three different packages on May 26. The action on part of the sanitation directorate also provided the political figures to cash in on the issue and lead the protesters up to the gates of the Mayor's office. As the election season starts, the candidates are trying to capitalise on the issues pertaining to the residents of the city, of which a large number are CDA employees.

Khaqan Abbasi condemns arrest of Qamar-ul-Islam by NAB

Shahid Khaqan Abbasi, while addressing the public rally, said former military dictator General (ret'd) Pervez Musharraf created NAB to eliminate PML-N from Pakistan.
