
**DISCLOSURE OF MATERIAL INFORMATION  
REVERSAL OF FEDERAL WORKER WELFARE FUND (WWF) AND PROVISIONING  
OF SINDH WORKER WELFARE FUND (SWWF) IN ATLAS FUNDS AND ATLAS  
MERAJ**

Pursuant of Regulation 5.19.13(c) of the Rule Book of Pakistan Stock Exchange and Section 96 of the Securities Act, 2015 we wish to inform that the Mutual Fund Association of Pakistan (MUFAP) in its extraordinary general meeting held on January 11, 2017 at 4:30 p.m. has decided for the reversal of Federal WWF and provisioning of SWWF from May 21, 2015 by the collective investments schemes managed by Asset Management Companies to be implemented on January 12, 2017. MUFAP has communicated the decision to Securities & Exchange Commission of Pakistan.
