

BOARD MEETING - 67<sup>TH</sup> BOARD OF DIRECTORS MEETING RESULTS FOR  
THE ISSUANCE OF 24.745% RIGHT SHARES OF THE BANK**

We are pleased to inform that the Board of Directors of the Bank in its 67<sup>th</sup> meeting held on Wednesday, December, 11, 2013, have decided to issue 2,4745 Right shares for every 10 Shares held (or 24.745%) at PKR 10 per shares in line with Bank's Capital Restructuring Plan as approved by the Shareholders of the Bank in its Extraordinary General Meeting held on January 17, 2013.

Further, the Board also approved the shifting of Bank's registered address from the province of Sindh to the Federal Capital Territory subject to regulatory approvals and compliances.

The Share Transfer Books of the Bank will be closed from December 26, 2013, to January 1, 2014 (both days inclusive) to determine the entitlement of Right shares.
