This is to notify that consequent to suspension of trading in the **Ordinary Shares** (Security Symbol: **SCLL**) ("**Said Securities**") of Standard Chartered Leasing Limited ("the Issuer") by the Pakistan Stock Exchange Limited ("PSX") with effect from June 13, 2016, as notified by PSX vide notice no. PSX/N-3426 dated May 31, 2016, the Central Depository Company of Pakistan Limited has decided under Regulation 5.3.1 of the CDC Regulations to suspend the CDS Eligibility of the Said Securities of the Issuer with effect from **Start of Day on June 13, 2016**.
