This is to notify that consequent to restoration of trading in the **Ordinary Shares** ("said Securities") of **Service Fabrics Limited** ("the Issuer") by the Pakistan Stock Exchange Limited ("PSX") with immediate effect, as notified by PSX vide notice no. PSX/N-3230 dated May 19, 2016 received by CDC on May 20, 2016, CDC has, pursuant to Regulation 5.4.2 of the CDC Regulations, decided to restore the CDS Eligibility of the said Securities with immediate effect.
