Pursuant to the Order dated 13 January 2014, of the Honorable Lahore High Court, Rawalpindi Bench, Rawalpindi, in respect of Petition CO NO: 2 of 2013, a joint Extraordinary General Meeting of the shareholders of Suhail Jute Mills Limited and (Colony) Sarhad Textile Mills Limited was called on Monday 17 February 2014 at 1500 Hours at the common Registered Office of both Companies, 125, Murree Road, Rawalpindi.

The subject meeting was adjourned to 31 March 2014 and subsequently to 15 April 2014 at the request of the representatives of National Investment Trust (an institutional shareholder) and with the consent of the shareholders present.

The adjourned Meeting reconvened on Tuesday 15 April 2014 and considered and approved the Scheme of Arrangement involving a Merger.
