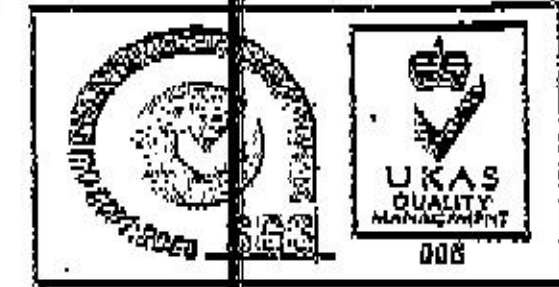

Dear Sir,

Please refer to your Letter No.KSE/Gen-11507, Dated: 17-12-2008 regarding failure to declare dividend and/or bonus certificates for five years.

You are kindly informed in this regard as under:-

1. The Companies Ordinance, 1984, only empower a company to pay dividend out of profits, please refer section 249 which is reproduced as follow:-

Section 249 "Dividend to be paid only out of profits: No dividend shall be paid by a company otherwise than out of profits of the company"

2. Articles of Association of our company also put some conditions/restrictions to permit for payment of dividend, please refer Article Clause No.96 which is reproduced as under:-

96. "No dividend except out of profits. No dividend shall be paid otherwise than out of the year or any other undistributed profits from prior years "

3. Shahzad Textile Mills Limited incurred loss amounting to Rs. 26,419,136/= (Twenty Six Million Four Hundred Nineteen Thousand one Hundred Thirty Six Only) and Rs. 668,928/= (Six Hundred Sixty Eight Thousand Nine Hundred Twenty Eight Only) for the year ended 30-06-2007 and 30-06-2008 respectively
