**The Resource Group Provides Operational Update:** *Company reports performance consistent with management expectations in April - June 2009 and provides guidance for fiscal 2010*

**Karachi, August 7, 2009** – The Resource Group ("TRG" or the "Company") is pleased to provide the following operational update in line with its commitment at its most recent Annual General Meeting to update its shareholders in July / August 2009 on its ongoing performance.

- The Company completed within the second calendar quarter of 2009 the restructuring of its TRG Customer Solutions operating subsidiary. Management estimates that subsequent to ramp of contracts with a leading U.S. telecommunications services provider and a global consumer electronics product company, TRG Customer Solutions had, on an unaudited basis, earnings before depreciation, taxes and amortization (EBITDA) of approximately Rupees 115 million in the month of June 2009. Management expects similar monthly results during the third quarter of 2009.
- The Company has signed (through its TRG Customer Solutions subsidiary) contracts during the last quarter with a leading global financial institution and with a leading U.S. office products supplier. The contract with the financial sector client is in the contact center outsourcing segment and represents TRG's first significant entry into the non-insurance financial
