

This is to inform you that I, Syed Hyder Ali has agreed with Mitsubishi Corporation of Japan for the renouncement by Mitsubishi Corporation in my favor of letters of rights of Tri-Pack Films Limited in respect of 200,000 rights shares of that company (Tri-Pack Films) being Issued by Tri-Pack Films.
