This is to notify that pursuant to letter dated February 23, 2015 of Unilever Pakistan Limited ("Issuer") along with Special Resolution dated April 26, 2013 passed by the members of the Issuer requiring revocation of CDS Eligibility of Ordinary Shares ("Said Securities") of the Issuer and in view of delisting of the Said Securities by Karachi Stock Exchange Limited, Lahore Stock Exchange Limited and Islamabad Stock Exchange Limited as notified vide notice no. KSE/N-4349 dated August 13, 2013, notice no. 4354 dated August 20, 2013 and notice LC/13/186 dated August 30, 2013, respectively, consequent to buy back of the Said Securities by the Sponsor of the Issuer, CDC intends to revoke the CDS Eligibility of the Said Securities of the Issuer with effect from March 25, 2015 in accordance with the CDC Regulations.
