



## **NOTICE FOR ALL MEMBERS**

### **PHASING OUT OF COT WITH MARGIN FINANCING**

This refers to our earlier notice number KSE/N-2631 dated April 21, 2004 whereby revised schedule for Phasing-out of Carryover (COT) Market was communicated amongst the market participants.

Keeping in view the queries from the brokerage houses regarding methodology of weekly gradual reduction of COT positions by members, an illustration is enclosed herewith to elaborate the reduction process for the convenience. Accordingly, members cannot exceed their position from the limit in each scrip to be determined on the weekly basis considering their outstanding position as of June 7, 2005.

In view of the above, members are requested to monitor their respective COT positions on regular basis and ensure compliance with the same all the time. Further, the Exchange shall also monitor scrip-wise outstanding positions of all members individually on daily and weekly basis and in case of non-compliance, necessary action will be initiated accordingly.

All members are requested to kindly note the same.
