Subject: **NOTICE OF REMOVAL OF SUSPENSION OF CDS ELIGIBILITY OF ORDINARY SHARES OF S. G. FIBRE LIMITED UNDER THE CDC REGULATIONS**

By our notice dated March 09, 2011 issued to S. G. Fibre Limited (hereinafter referred to as the "Issuer") under Regulation 5.3.2 of the Central Depository Company of Pakistan Limited Regulations ("the CDC Regulations"), we suspended the CDS Eligibility of ordinary shares ("said Securities") of the Issuer with effect from March 10, 2011, on account of its failure to settle the CDC invoices in accordance with the Schedule of Fees & Deposits in discharge of its obligation under the CDC Regulations.
