**NOTICE OF DECLARATION OF CDS ELIGIBLE SECURITY**

We refer to your application under Regulation 5.1.8 of the Central Depository Company of Pakistan Limited Regulations ("the Regulations") for declaration of Units of ABL Cash Fund (Open-end Scheme) managed by ABL Asset Management Company Limited as CDS Eligible Securities and are pleased to inform you that CDC has, under Regulation 5.1.11 of the Regulations, accepted the application and a formal notice under Regulation 5.1.1 of the Regulations is enclosed.

In the meantime, you are requested to advise the relevant officials of your company to make necessary arrangements for the smooth induction of aforesaid units into the CDS.
