This is to notify that in view of restoration of trading in the Ordinary Shares ("said Securities") of Yousaf Weaving Mills Limited by Karachi Stock Exchange Limited as notified vide notice no. KSE/N-2816 dated May 18, 2015, CDC has, pursuant to Regulation 5.4.2 of the CDC Regulations, decided to restore the CDS Eligibility of the said Securities with immediate effect.

In the view of the above, our notice no. CDC/CS/070/2015 dated March 20, 2015 suspending the CDS Eligibility of the said Securities pursuant to Regulation 5.3.1 read with Regulation 5.4.1 of the CDC Regulations, shall stand removed from immediate effect.
