**Induction of Cash Settled Futures (CSF) and Stock Index Futures Contract (SIFC) Markets in Risk Management System (RMS)**

**Dear Clearing Members and Settling Banks,**

This is with reference to our Circular No. **NCCPL/CM/JULY-18/22** Dated **July 27, 2018** pertaining to the Go-Live of Comprehensive Risk Management System (RMS) by NCCPL.

In this respect, NCCPL is pleased to announce that the induction of two more markets in **NCCPL RMS System** shall **Go-Live** effective from **Monday, November 19, 2018** for **CSF and SIFC Markets**.

Following points are important to be noted in this regards:

**1. How to access new Markets module**

**2. Discontinuation of Services**

Consequently, the following will be discontinued from **Monday, November 19, 2018**:

- a. PSX CMS functions related to the RMS of CSF / SIFC Markets.
- b. PSX RMS for CSF / SIFC Markets.

**3. New Upload & Download Formats for new Markets**

Effective from **Monday, November 19, 2018**, following upload / download formats as attached in **Annexure** shall be used in NCCPL RMS:

- a. CMS Upload
- b. Pledge Upload
