ELIGIBLE SECURITIES FOR SHORT SALES UNDER SHORT SELLING REGULATIONS

As per clause 8 of the Regulations for Short Selling under Ready Market, 2002, read with Annexure "A" attached to said regulations, the companies which are approved from time to time by the Board for the purpose of CFS (then COT) facility under Continuous Funding System Regulations 2006 and available through KATS shall be eligible securities for short sales under the said regulations. Therefore, the following list of securities will be eligible for short sales effective from Wednesday, June 11, 2008:
