Re: NOTICE OF REVOCATION OF CDS ELIGIBILITY OF ORDINARY SHARES OF NORRIE TEXTILE MILLS LIMITED UNDER REGULATION 5.3 OF CDCPL REGULATIONS

- A. WHEREAS** in connection with the declaration of the ordinary shares (the "Securities") of Norrie Textile Mills Limited (the "Company") as Eligible Securities for the purposes of the Central Depository System ("CDS") established by the Central Depository Company of Pakistan Limited ("CDC"), on 29 February 2008 the Company represented to CDC in the Issuer Admission Form that the paid-up capital of the Company was Rs.598,600,000 divided into 59,860,000 ordinary shares of Rs.10 each;
- B. WHEREAS** in further pursuance of the said declaration and of the requirements of Regulation 5.1.1(b) of the Central Depository Company of Pakistan Limited Regulations ("CDCPL Regulations"), the Company further represented to CDC that the paid-up capital of the Company was Rs.598,600,000 divided into 59,860,000 ordinary shares of Rs.10 each;
- C. WHEREAS** as a result of the foregoing, as of the date of this notice of revocation 59,845,300 Securities of the Company have been entered in the CDS as Book-entry Securities;
- D. WHEREAS** upon recent verification of the paid-up capital of the Company CDC has learned that the said representations made to CDC by the Company are false and that the actual paid-up capital of the Company is Rs.48,600,000 divided into 4,860,000 ordinary shares of Rs.10 each;
- E. WHEREAS**, in view of the foregoing situation, CDC:
- (i) has concluded that the eligibility criteria set out in Regulation 5.1.1(f), namely that the declaration of the Securities of the Company as Eligible Securities be in the public interest, has ceased to be met; and
