**Suspension of Trading Rights of  
Al Mal Securities and Services Limited**

This is to notify that pursuant to the directive of the Securities and Exchange Commission of Pakistan to Central Depository Company of Pakistan Limited (CDC) vide letter no. SMD-South/CDC(2256)/2008 dated September 02, 2008, CDC vide its Notice dated September 2, 2008 has suspended the admission of CDS Participant Account of Al Mal Securities and Services Limited, a corporate Brokerage House of Karachi Stock Exchange (Guarantee) Limited with immediate effect.

Further, pursuant to NCCPL Regulation No. 18.3.1, NCCPL vide its Notice dated September 3, 2008 has also suspended access of the said Brokerage House to NCSS with immediate effect until further order.

As a consequence thereof and to protect the interest of investors under these circumstances, the Governing Board of Directors of the Exchange has decided to suspend with immediate effect the trading rights of M/s. Al-Mal Securities & Services Limited bearing Code No. M-083 until further notice.
