**IMPLEMENTATION OF NEW STANDARDIZED SUB-ACCOUNT OPENING FORM**

This is further to our circular dated July 18, 2009 implementing the new Standardized Sub-Account Opening Form ("SAOF") on the directive of Securities and Exchange Commission of Pakistan, which has also become part of CDC Regulations.
