Please refer to your letter dated January 13, 2010 on the subject noted above.

I have been directed to inform you that the Commission has been pleased to allow Fatima Fertilizer Company Limited (the Company) to extend the bidding period for one day i.e. January 14, 2010 subject to the following conditions.

- (i) The Company shall not accept any fresh bid application after 1:00 pm on January 14, 2010;
