You are requested to forward the Government's directives to your regulated entities for taking necessary actions to freeze the funds of the nature mentioned in the attached S.R.O.

As advised through our earlier correspondence you are also requested to require your regulated entities to provide compliance report, even if nil, on the action required in the attached S.R.O., on a fortnightly basis. Additionally, you are to submit a consolidated fortnightly compliance report based on the reports submitted by the regulated entities to the Securities and Exchange Commission of Pakistan for sharing with the Ministry of Foreign Affairs.
