ELIGIBLE SECURITIES FOR SHORT SALE UNDER SHORT SELLING REGULATIONS

Further to our Notice No.KSE/N-6858 dated December 7, 2009 on the subject whereby the Exchange notified that KSE 30 index companies shall be eligible for short selling under Ready market. Now the Exchange vide its Notice No. KSE/N-4241 dated August 13, 2010 recomposed the KSE-30 index, which is effective from August 16, 2010.

In view of above the Exchange in terms of 3(i) of Regulations for Short Selling under Ready Market, 2002, has decided to replace the existing list of securities eligible for short selling under Ready Market with re-composed KSE-30 index companies with effect from Monday September 20, 2010.
