LIST OF SECURITIES ELIGIBLE FOR SHORT SELLING UNDER READY MARKET

The Exchange, in terms of the regulation 8(i) of Regulations for Short Selling under Ready Market, 2002, with prior approval of SECP vide its letter No. SMD/SE/2(3)2002 dated February 17, 2011 has replaced the existing list of securities eligible for Short Selling under Ready Market with re-composed KSE-30 Index companies which will remain applicable till launch of Securities Lending and Borrowing (SLB) mechanism or next re-composition of KSE-30 Index, whichever comes earlier.

Further the Exchange in terms of its regulation 8(ii) of the said regulations is required to give at least 30 days prior notice to the market participants for including or excluding any security from the list of securities eligible for Short Selling, therefore, the following 30 Securities will be eligible for Short Selling under Ready Market with effect from Monday, March 21, 2011:
