2. In this respect, NCCPL has arranged further Mock Sessions of the Margin Trading System, in coordination with the Karachi Stock Exchange, as per the following schedule:

3. Following User ID and Password will be used to log-on into Margin Trading System (Mock System) as Financier and Financee:

- For Broker Clearing Members (as Financiers and Financees):

➤ BFF (member code) 01; and

- For Non-Broker Clearing Members (as Financiers only):

➤ NBF (*member code) 01

*(member code for Non-Broker Clearing Members will be given by NCCPL)

4. Please note that the Margin Trading System is a separate system from the Karachi Automated Trading System (KATS) and National Clearing and Settlement System (NCSS), therefore, all Clearing Members are required to arrange a separate Personal Computer (PC) for an exclusive use of the Margin Trading System.
