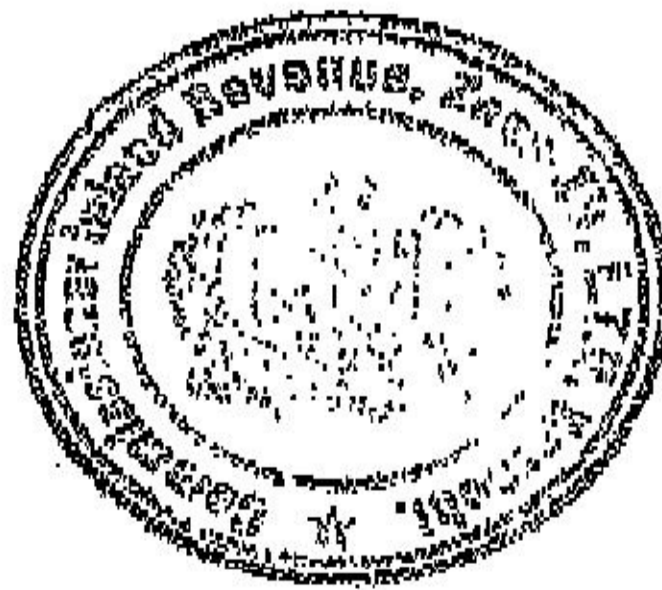

**EXEMPTION CERTIFICATE NO 80 U/S.153(4)  
OF THE INCOME TAX ORDINANCE, 2001.**

In exercise of the power conferred by sub-section (4) of Section 153 of the Income Tax Ordinance, 2001 read with clause (xvii) of SRO 586(1)/91 dated 30-06-1991, it is hereby directed that no deduction of tax shall be made under sub-section (1) of Section 153 of the Income Tax Ordinance, 2001, in the case of M/S. KARACHI STOCK EXCHANGE (GUARANTEE) LIMITED, Karachi holding National Tax Number # 34-01-0710853-2 from payments representing services rendered by it.

It is however, directed that tax already deducted under sub-section (1) of Section 153 of the Income Tax Ordinance, 2001 shall not be refunded to the taxpayer but shall be deposited into Government Treasury.

This exemption certificate is valid upto 30-06-2013, unless revoked / cancelled earlier.
