ALL THE LISTED COMPANIES AND ISSUER OF LISTED SECURITIES

Attention of all the Listed Companies and Issuers of Listed Securities is invited to Circular No. 44 of 2015 dated December 8, 2015 issued by the Securities & Exchange Commission of Pakistan, whereby it has been advised to ensure compliance of Section 204-A(2) of the Companies Ordinance, 1984 which requires appointment of an independent Share Registrar, which is registered with SECP under the Ballotter and Transfer Agents Rules, 2015.

It has been observed that a number of Listed Companies and Issuers of Listed Securities have not appointed the independent Share Registrar and Transfer Agent as required under the Ordinance. It has further been observed that in some of the cases the Share Registrar appointed by the Companies have not been registered with the Securities & Exchange Commission of Pakistan as required under the Ballotter and Transfer Agents Rules, 2015.

In view of above, all the Listed Companies and Issuers of Listed Securities are advised to ensure compliance of the directive issued by the Securities & Exchange Commission of Pakistan in its above Circular latest by December 31, 2015 and confirm the same to the Exchange (Copy attached).

CIRCULAR 44 OF 2015

All listed companies are required to comply with the aforesaid direction by December 31, 2015.
