This is with reference to the captioned subject and the PSX letter dated 16th June 2017 (Ref No. PSX/GEN-4312) (the "Letter") for allocation of dates for Publication of Prospectus, Book Building and Public Subscription of Inbox Business Technologies Limited ("inbox" or the "Company").
