Reference is made to Access to Inside Information Regulations, 2016 notified vide S.R.O. 73 (I)/2016 dated February 01, 2016 issued by Securities & Exchange Commission of Pakistan (SECP) which requires all listed companies to maintain and regularly update a register to enlist persons employed under contract who have access to inside information in the format specified by SECP.

SECP being the Apex Regulator and PSX being Frontline Regulator, have given due importance to ensure compliance with Access to Inside Information Regulations, 2016.
